- Warm welcome to new board member Greg Jones from Skyline! Introductions from existing board members

PRESENTATION: DT Waste Project Team + Q&A

- Robertson Reid, a recap and heads up following his last visit in September, wrapping up user fee study that had been in the works, blue box change now in effect
- Council has provided funding for downtown & a few others left out of this transition, need to sort out what we would like to do for next year
- Downtown infrastructure improvements on Wyndham Street starting 2026
- Idea of user fee, we need more revenue to support it especially if council aims to keep taxes low & aligns with areas outside of downtown that are not eligible
- Starting first week of February, user fee notices will start
- They want to recruit a group of property owners, business owners, anyone interested in managing this contract
- What do you want for waste collection? Recycling or not?
- Ability to be transparent on cost based on community asks
- Inquire on who do we want to run the program?
- For 2025, council provided funding for downtown to maintain paid waste removal, however, businesses will have to pay for waste removal (residential exempt)
- 6 days a week/daily removal downtown compared to residential which is 1 day per week
- After downtown revitalization, we will have underground bins, but short term is what we are inquiring on.
- Downtown has higher tax density; owners do not want to pay more money for waste removal
- City of Toronto on full user fee (privatized removal), Wellington County has bag program

3. Chair Updates - Chuck

- Spirit of the Season; December was a huge success & very busy! Debrief last week with SOTS committee; some adjustments to go forward
- Vendors were very happy based on surveys & feedback
- Trying to secure a Strategic Planning Date (Before End of March)

4. Treasurer Update - Richard

- Waiting on financials from Jenny (accountant) and from Spirit of The Season, should see it likely in March
- SOTS financials were revenue neutral, after & including the \$25,000 donation to KKF
 \$25,000 for amortization for the huts
- \$85,000 in sponsorships for SOTS 2024

5. City Updates - Stacey & James

- Lots of open houses coming up for Downtown projects, planning a session with downtown Heritage Association Feb 27th to provide input
- Downtown Heights study draft official plan amendment released January 16th, open house on Tuesday Feb 4th at city hall, and stat meeting on February 11th with council
- St. George's square open house on February 12th; important for DGBA to see/share what supports businesses & day-to-day activation (two proposed options available online)
- Affordable housing incentive programs going to council February 11th; if approval is granted there is a 20 day appeal period. Program can be launched in March
- Downtown Networking Group (Big Dig) was beneficial/helpful to share ideas, as we get closer to construction.
- Looking at creating a guide for businesses to prepare for the dig, parking accommodation, checklists for business, possible uses for SOTS huts during construction
- Importance of in person events, to create a fulsome and informative experience
- DGBA looking at sending out mass texts to membership to communicate information as opposed to newsletter (dwindling interaction)
- Chuck: proposing having speaker from Kincardine at the AGM to share experience on their construction downtown; as we have a large turn out in person for AGM

6. Motion: Derrick - Rename the "Guelph Community Santa Parade" to "The Santa Claus Parade" seconded by Bryan Steele

- Feels it better aligns with our mission in marketing direction, to be more specific and get back to traditional holiday activities
- We (Guelph) may have one of (if not THE) largest night time parades in Ontario Derrick Motion to Amend: to "Guelph Santa Claus Parade" seconded by Isade; all in favour motion carries

9. CLC Updates - Derrick

- Positive feedback from businesses downtown; play with clay is booking children's birthday parties again - increased business post encampment relocation
- Still downtown police officers enforcing open air drug use policies
- Meeting with Chief Cobey (Police) regarding crowd control come spring, now that funding has been put through to Royal City Mission (\$350,000) from CHC
- To ensure downtown maintains a positive/drug free environment

10. Motion: Pina - To make the illuminated lights on the buildings all white, excluding special events. Themed lighting shall commence no more than 5 days prior & end 2 days after an event

- intent is that when switched to colour for events, they stand out better downtown to really encompass the celebration of the event
- Currently they are a mish-mash of colours, appears "tacky"
- Colours don't stand out when lights are intentionally changed to support holiday/ event
- Intent to "colour the downtown with purpose"

11. Attractions Update - Pina

- For SOTS: Ended with 2.6 million views, over 20K shares, over 37K likes, over 60K engagements
- All promotional reals saw over 50K & one viral video reaching over 485K views a large Toronto audience & carousel that reached over 164K people, 3900 shares, over 800 saves & 41K likes
- Positive reviews/feedback from patrons, well advertised, fire dancers were well received, praise for the community involvement, the red heart photo structure was a huge success
- Raised \$34000 for keep kids fed at home

- Bryan & Pina's windows won the window contest; donated their downtown dollars to Guelph families
- Next year would really like to have more lights throughout the downtown
- Love week, February 10th-17th, shop the streets
- Take a photo at the heart & tag your favourite store & you have a chance to win downtown \$\$\$
- Rich: inquiries on summer garage sale. Proposed date is July 12th, on upper Wyndham Street
- Working on estimates/cost to close Wyndham street for the garage sale
- Is it possible to obtain a approximate price list (from city) on cost to close down different sections of the downtown for an event? (Stacey to inquire)
