- St George's square public engagement has ended; consolidating feedback for review
- Downtown Heights Open House/stat public meeting held in January; consolidating feedback
- Developing the construction medication plan. Propose store front downtown to be a place where residents/business owners can connect with city staff and contractors
- Looking to have a downtown ambassador to be the face of the program: to be the go to person for business owners to go to in order to trouble shoot issues/ask questions (direct point of contact)
- Potential expansion map (submitted by chuck); the area may be better to match the downtown secondary plan map (ideally make them match/ as close as possible)
- Q: are businesses that are significantly impacted by the construction work to be compensated by the city
 - A: not part of Guelph's meditation plan (under the municipal act they are not allowed to provide direct financial compensation).
- Q: what was the feedback from the downtown heights project (in favour or opposed on height)
 - A: mixed response; 50/50 on individuals allowing more height on buildings vs those against to protect the current downtown landscape

7. CLC Updates - Derrick

- Derrick attended opening of Delhi Street (38 people now have access to a bed)
- Looking to create strategy to notify the public
- Inquiring on where to put a day time hub with access to basic resources (food, medical etc) whose job is it to find a day time shelter space - can the city assist? (Stacey to inquire with city strategy team)

- Presently working on Easter event; golden eggs being hidden throughout downtown businesses
