3. Treasurers Report - Richard Overland

- Discussed at AGM (Richard unavailable)

4. Chair Updates - Charles Nash

- Attended the garbage user fee meeting this morning, still some uncertainty on what system they (the city are going to go with), no set fees identified yet, - discussed underground garbage plan, proposed 100m distance to walk to dispose of trash in designated areas
- General consensus from business owners is why do we have to pay, what will we have to pay? Residential vs businesses, who pays what?
- AGM: felt the DGBA portion was well received
- Positive feedback on the direction with the new board
- There is not \$900,000 in surplus, it's closer to \$400,000 (\$500,000 was injected from the government funding for the lighting project)

5. City Updates - James Goodram & Stacey Laughlin

- Congrats on a successful AGM. A recording of the meeting will be shared with Alex.
- DT Infrastructure
 - Maxine has been doing walkabouts with Alex Turgeon visiting businesses. She is tracking the information we are receiving from businesses. In situations where the owner isn't available, she's reaching out with a follow-up email.
 - Online comments on St. George's Square are open until end of day tomorrow (May 29, 2025) – https://haveyoursay.guelph.ca/en/projects/wyndham-and-square
 - Watch for the report at Committee of the Whole on July 8. It will be released
 publicly by June 27 with the Council Agenda. If the Board would like to delegate,
 the registration/written submission deadline is July 4 at 10am. The report will
 cover construction mitigation, construction staging/sequencing, and the design of
 St. George's Square similar content to what was presented at the AGM.
 - Baker District we have retained a contractor to do the surface works for Baker Street. The work will be coordinated with the Enbridge, Alectra and annual paving work. Communication about Baker District/Baker Street and changes to access will increase as this work gets started.

- Keep Kids Fed, to utilize 1 spot for themselves to sell one of a kind bags to raise money/create awareness of the program
